Terms and Conditions Participation IVth Lustrum S.A. Comitas, 2022 (17 November to 3 December)

Article 1: Costs of Participation

- 1. The stated prices include participation for the stated activity. The Lustrum Committee does not charge VAT over the costs of participation.
- 2. The stated ticket package prices include the activities and events as stated in article 1.2.
 - 1. Package of Immortality: Opening Party, Family Day, Chic Day, Friends from the Past Day, Gala
 - 2. Package of Harmony: Opening Party, Family Day, Friends from the Past Day, Gala
 - 3. Package of Invisibility: Opening Party, Family Day, Friends from the Past Day
 - 4. Package of Legacy: Opening Party, Old Members Day, Chic Day, Gala
 - 5. Package of Immortality + Old Members Day: Opening Party, Old Members Day, Family Day, Chic Day, Friends from the Past Day, Gala
- 3. Prices are stated in euros, unless stated otherwise.
- 4. The ticket packages are limited to members of S.A. Comitas and Old Members of S.A. Comitas. The signup is on a first come, first serve basis. The Lustrum Committee is entitled to make exceptions to the rules in this paragraph if it considers this necessary.
- 5. The Loose Ticket Sale is open to members and Friends of members of S.A. Comitas. The signup is on a first come, first serve basis. The Lustrum Committee is entitled to make exceptions to the rules in this paragraph if it considers this necessary.

Article 2: Payment Conditions

- 1. The payment for Ticket Packages can be done in one (1) or more installments, with a maximum of seven (7).
 - a. If one instalment is chosen, the payment must be fulfilled at the moment of purchase. Payments are solely collected through See Tickets B.V, hereafter referred to as See Tickets. Terms and Conditions of See Tickets apply. The Lustrum Committee is entitled to make exceptions to the rules in this paragraph if it considers this necessary.
 - b. If two (2) or more instalments are chosen, the first term must be fulfilled at the moment of purchase in the ticket shop provided by See Tickets. First term payments are solely collected through See Tickets. Terms and Conditions of See Tickets apply. By paying the first term, buyer consents to paying all remaining terms in full before 8 November 2022. All remaining terms will be collected through NLCollect B.V. Article 3: Cancellation of participation

 Until 90 (ninety) days prior to the Lustrum – the 16th of August 2022 at the latest – you can cancel your package and receive a full refund, excluding service fees/costs and/or transaction fees/costs charged at the moment of the initial purchase. After this date we will charge 50% of the full price.

- 2. Until 60 (sixty) days prior to the Lustrum the 15th of August 2022 at the latest you can cancel your package and receive a 50% refund, excluding service fees/costs and/or transaction fees/costs charged at the moment of the initial purchase. After this date we will charge the full price.
- 3. Cancellation can be done exclusively via an email to lucosacomitas@hotelschool.nl.
- 4. The costs owed after late cancellation will be recovered in the way described in section 1 and 2 of this article.

Article 4: Cancellation of the day / Date Change

- 1. The Lustrum will continue or be cancelled in line with the measures of the Dutch Rijksinstituut voor Volksgezondheid en Milieu: RIVM (National Institute for Health and Environment) as well as local and public authorities.
